6. Accidental release measures

Personal precautions, protective equipment and emergency procedures Remove all sources of ignition. Increase ventilation. Evacuate all unprotected personnel. Do not breathe dust. Wear respiratory protection and full protective clothing to minimise exposure. Sweep up material avoiding dust generation - dampen spilled material with water if suitable to avoid airborne dust, OR where possible use dustless methods such as vacuum to collect the material; then transfer material in to suitable vapour tight labelled containers for subsequent recycling or disposal. 7. Handling and storage

Precautions for Safe Handling Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dust in the work atmosphere. Avoid inhalation of dust, and skin or eye contact. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities Store in a cool, dry, well-ventilated area, out of direct sunlight and moisture. Store in labelled, corrosion-resistant containers. Keep containers tightly closed. Store away from bases, water and other incompatible materials. Have appropriate fire extinguishers available in and near the storage area. Ensure that storage conditions comply with applicable local and national regulations.

8. Exposure controls/personal protection

Appropriate engineering controls Provide sufficient ventilation to keep airborne levels below the exposure limits. Where dusts are generated, particularly in enclosed areas, and natural ventilation is inadequate, a local exhaust ventilation system is required.

Respiratory Protection If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable dust/particulate filter should be used. Reference should be made to Australian/New Zealand Standards AS/NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.
